The Republic of Kosovo has received financing from the World Bank toward the cost of the Kosovo Comprehensive Approach to Health System Strengthening Project (KOMPAS) and intends to apply part of the proceeds toward payments under the contract for Procurement of transport vehicles for medical waste (MW).
2. The Ministry of Health now invites sealed Bids from eligible Bidders for the supply and delivery of medical waste trucks, including warranty and related services. The vehicles shall be specially designed for safe transport of infectious healthcare waste in compliance with applicable safety and environmental standards, in accordance with the technical specifications set forth in the Bidding Document. The delivery period shall be specified in the Bidding Document.
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's Procurement Regulations for IPF Borrowers (November 2020, revised February 2025) and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from the Ministry of Health, KOMPAS Project Implementation Unit (PIU), Attn: Procurement Specialist, blerim.cerkini@rks-gov.net and inspect the bidding document during office hours **09:00 to 16:00** at the address given below.
5. The bidding document in English may be obtained by interested Bidders upon the submission of a written application to the address below. No fee will be charged. The document will be sent by electronic mail.
6. Bids must be delivered to the address below on or before **30 June 2026 at 14:00 PM**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **30 June 2026 at 14:00 PM**.

7. All Bids must be accompanied by a Bid Security of EUR 5,172.00 (five thousand one hundred seventy-two euros) or an equivalent amount in a freely convertible currency.
8. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
