The Government of Kosovo (GoK) has received financing from the World Bank toward the cost of the Kosovo Emergency Covid-19 Project, and intends to apply part of the proceeds toward payments under the contract "Procurement of Laboratory equipment's, Laboratory Refrigerators, Microbiology safety cabinets, Microscopes, System for automatic identification of microorganisms and antimicrobial susceptibility testing, System for automatic reading and interpretation of AST & ID, kits and supplies"

7. All Bids must be accompanied by a Bid Security:
